At the time of this writing there have been no break-ins that have been reported to BCL. Winter tends to be the time there are break-ins because a lot of the homes are vacant for several months.

Please if you are a summer or occasional resident and even if you are full time, it is in your best interest to have an alarm installed, and to have you driveway plowed, so even if you are not here, it looks like you are.

BOARD OF DIRECTORS

Every fall meeting 5 members of the Board come up for election. We are always looking for new people to run for the Board. This year we have 2 incumbents not running and one other board member who may be leaving early. Please consider running for the Board and giving back to your community.

The requirements for running for the Board are, you must be a member in good standing, this means your dues are current and you have no outstanding citations.

You must be a member of BCL, meaning that you must have a property in BCL with your name on the deed.

The terms are for 3 years and you will be appointed to head a committee by the elected President.

For your information, all officers are elected by the Board of Directors at a meeting immediately following the Fall General Meeting.

One of our major problems are minors driving golf carts and ATV's. Please be aware that a child must be 12 years or older to drive a golf cart and must be accompanied by someone who is 15 or older. Once they reach 16 they may drive by themselves. Drivers of ATV's must be at least 16. It is in your best interest to make sure that your child is capable of driving these vehicles safely. They are dangerous tools in the hands of a reckless driver.

MAINTENANCE COMMITTEE BOB GORDON

This has been one long, cold winter! For the Maintenance Department it meant many long days plowing snow and spreading salt and anti-skid. In between storms we renovated the stairwell in Stewart Hall with new walls, ceiling and lighting. We purchased a new compact tractor with a mower and a large blower to clean our roads. Last fall we hired a professional contractor to begin trimming trees along our roadways. This contract included about a third of our roads. We plan to continue this work in the coming years to cover all our roads.

In the next few months we plan on replacing the decking around Stewart Hall and we will be replacing and enlarging several storm water drainage pipes to improve the flow of surface water during heavy storms. We recently hired Jim Halpin as our second full time maintenance employee. Please stop and say hello to Jim and our maintenance superintendent, Keith Richards, when you see them in the community. Have a great summer.

RULES COMMITTEE BILL ALLISON

Last spring the BCLCA presented the new Tree Preservation Rules to protect the forest that surrounds and fills our community. Many thanks to all members for submitting applications for tree removal over the years and to those who've complied with the new rules. This gives the community a chance to review any tree cutting before it happens in order to maintain our precious natural resource that protects Bear Creek Lake and enhances property values. The Tree Preservation Rules were a huge step, and general acceptance confirms that members appreciate its enactment.

This year the Civic Association Board has passed two further

rules, one a minor addition and the other more consequential. The first change would be on the rule book's page 12. Under the information section, part 1, please add "snowmobiles" to the list of Sport Vehicles. Hearing the whine of snowmobiles during this snowy winter told us to include them.

The other rule change would be a surcharge on permits and approvals, if a property owner initiates a project prior to applying for the Association's approval. For years the Association has required permits and approvals for building, construction, sheds, driveways and tree removal. However, there have never been any consequences for disregarding the approval process.

To dissuade property owners from disregarding the process, the Board passed the following: To cover administrative costs, a surcharge of two hundred fifty (\$250.00) dollars shall be added to the fee for all permits or approvals required by the Civic Association for any type of activity or conduct, including building/construction permits, shed permits, driveway permits and approval for tree removal, if such activity or conduct is initiated prior to application for a permit or approval.

The penalty would be levied prior to Civic Association instituting any type of lawsuit or administrative proceeding, or similar action This provision should not be interpreted in any way to condone any such activity or conduct, but rather serves the purpose to cover extra administrative costs in processing "after the fact" permits or approvals.

Rule changes are effective as of June 1, 2011.

Thank you for your cooperation in keeping our community safe and orderly.


This is also the time of year when owners look at their lawns and consider applying fertilizer and weed control. PLEASE RECONSIDER! All of the chemicals that you put on your lawn wind up in the lake and our wells. If you would not mix fertilizer or weed killer in a glass of water and drink it, please do not put it on your lawn because we will all end up drinking it. If you live near the lake it is also a violation of state and federal law to use these products. Read the fine print on the bag. Lush lawns also are the favorite feeding ground for geese which add to our pollution problem.

As many of you know we are having a serious flooding problem in the community at the east end of the lake. The water is coming from 903 and causing many problems. We are going to need your help in trying to work with Harrisburg and PennDot to get some assistance with this problem. Please keep an eye on the BCLCA website for a future "call to action". We will post information there if we need owners to contact our legislators.

Here's hoping we all have a clean and green summer!

LAKE/DAM COMMITTEE

The winter ice season on the lake was as long as I can remember. As soon as the ice thawed, we saw an increase in Bald Eagle sightings. A few weeks ago I witnessed an Eagle ripping apart a freshly caught fish as it perched in a tree near my lakefront on the north shore.

Presently there are no issues with the Dam at this point with the exception of minor maintenance obligations. Our duty to carefully monitor the toe seepage seems to be our only real concern as the present (not overly concerned as we have been monitoring the seepage for 15+ years now). It is our continued effort to monitor and control the Dam so we can be assured of safe operations for years to come. With the help of our Engineer, we have finalized our Emergency Action Plan (EAP) as required by the State DEP.

A few issues involving the lake will be looked at this spring and summer season – 1. Examining internal lakefront encroachments; including bulk heading all beaches on lake front lots. This is one issue that continues to be a challenge for the Board of Directors - 2. Controlling some storm water issues is another project that we will keep a watchful eye on....especially considering the development of the Recreation Park across Route 903. Speaking of which, in speaking with Township officials, I was assured that the standards for Erosion & Sediment Control & the Federal EPA guidelines for development will be adhered to prior to any earth disturbance. Everyone involved in this project understands that the property that is being developed is within an Exceptional Value (EV) watershed – the highest classification that can be given to a watershed. The regulations are strict!

As always, I remind everyone to read and follow the safe boating rules and regulations set forth by the PA Fish & Boat Commission. We are a private lake but our water is governed by the Commonwealth. The common issue is life jackets – the law states that all children 12 and under must wear a life jacket when in a boat & all occupants must have a lifejacket available on the boat.

We now have meeting rooms on the second floor that are available to the community and this spring one of our members will be starting an adult literacy program there. One of our members is creating a flower garden in the small back yard. A new project we are undertaking is to upgrade the library at the Carbon Co. jail, and soon hope to start a book group there.

Our most active project remains our weekly used book sales that take place every Saturday from noon to 4pm and the first Thursday of each month from 3pm to 7pm. If you haven't yet, do try our book sale. You'll find it is your newest favorite bookstore!

We are always looking for new members to join us in any or all of our endeavors. Membership is free and involves only being willing to be part of our "volunteer network" and get occasional emails about volunteer needs and opportunities.
