Over the past two years, Kathy has brought the Accounting in-house, resulting in a considerable savings from the elimination of the outside bookkeeping firm. As you can imagine, this required considerable time and effort by her, all on a volunteer basis. She should be extremely proud of her accomplishments, and the Board appreciates her efforts on behalf on the Community. The Office staff should be recognized as well. Barb and Pat were key members of the team that pulled off the transition, putting in considerable efforts as well, and having to learn several new systems.

I view the role of the Treasurer as having three main components:

- Accounting function preparing financial statements, paying bills, processing payroll
- Safeguarding the assets of BCLCA
- · Customer service

My objective over the next 12 months is to continue to build on the progress Kathy made on the Accounting systems, as well as taking a look at current Accounting policies and procedures and revamping them where necessary. Another focus area for me will be communication and transparency. Kathy began the process by placing certain financial information in the "Members Only" section of the website, and I intend to expand on that.

#### Understanding the Finances of BCLCA

From a communication standpoint, it is not practical for me to be able to respond to individual emails – we have over 870 Members. In an effort to accommodate everyone, I plan to implement a regularly scheduled monthly meeting, "Talk with the Treasurer" where Members may attend and ask financial and accounting questions about BCLCA. At some of these meetings I will plan to address a specific topic where we have received a number of Member questions.

At the first "Talk with the Treasurer" session, I plan to discuss the Reserve Study conducted last year. That session is scheduled for Saturday, September 10<sup>th</sup> at 11:15 AM at Stewart Hall. Generally I will plan to hold the monthly session at 11:15 AM the second Saturday of the month after the Crime Watch meeting, but the timing may change, so please check the "Members Only" section of the BCLCA website each month for the precise time.

I also plan to develop a Financial FAQ (frequently asked questions) page in the "Members Only" portion of the website. When I see a common theme in emails the Association receives or questions raised during the monthly sessions, I will do my best to post an answer there as well.

At the July Board Meeting, we approved the formation of a Finance Committee to assist the Treasurer in certain key areas. The principal duties of the Finance Committee and its Members are:

- Assistance with Accounting functions
- Development of Accounting policies and procedures
- Assistance in oversight of BCLCA Cash management
- Review of the annual Audit

#### WIND TURBINE PROJECT

A Wind Turbine Project is proposed on the Bethlehem Water Authority property near the Municipal Park on Route 903. As proposed, the closest turbines, 37 in all, will sit just on the other side of the turnpike. To those of us in BCL, that is slightly less than 1 mile (as the crow flies) from some of our homes. Many homes are within a 2 mile distance, and still others are within 3 miles. Some will be able to view them from their homes, and also from the lake. The impact on the wildlife of the area may be substantial, especially to our raptors and bats. To humans, the impact may vary from minimal to extreme. Some may or may not be affected by infrasound (which is not actually a sound, but more of a sensation, akin to motion sickness and heart palpitations), and other noises. These include snapping sounds in winter (from chunks of ice breaking off ) to the sound of continual airplanes over head. Some industrial wind areas run at night, and witnesses provide horror stories of sleep deprivation and lights flickering at all hours. Any of these can be experienced up to 3 miles away. At times they catch on fire, which can be extremely dangerous in a woodland area. We have a grassroots movement in place to prevent these behemoths (over 500 ft. tall not counting the blades!) from becoming an intrusion in our lives and potentially destroying our property values. To those who feel Wind projects should be everywhere because they are "green", please educate yourselves. They are manufactured with OIL and COAL, so are they truly green? I researched both sides before making MY decision to fight this. It's up to you... do you want BCL to remain as wonderful as it has been? If so, join us in our efforts. Join us at the Facebook page SAY NO to Bethlehem Water Shed Wind "Farm" Project or at SOAR(Save Our Allegany Ridges). Both sites contain a wealth of information. **Contact Penn Forest Township**, Attn: Zoning Board at pftsec@ptd.net expressing your opposition.

#### BCLCA BOARD POSITION ON THE WIND TURBINE FARM

During the Members' Comment section of the May 2016 General Meeting, several residents raised concerns about the proposed wind turbine farm. Part of the discussion was to understand what BCLCA's position was on the matter. The Board discussed the matter at the June 2016 Board meeting.

The decision was that the Board could not officially represent the Bear Creek Lakes community in opposition to the wind turbines as there are differing points of views within our own community; and therefore any stance taken would be contrary to the views of some within the BCL community. The Board did decide to issue a letter, which is posted on the Members' Only section of the website, to Penn Forest Township. The letter expressed the deep rooted purpose of BCL as a recreational community, and that the close proximity of an industrial facility would be in direct contradiction to achieving that purpose. The letter further went on identify some concerns where the current Zoning requirements are deficient.

We urge all of the Members to fully investigate the issue and use the democratic process to support their position. Potential websites to obtain information on the issue are the following:

# RULES COMMITTEE Rich Berger

The Rules Committee is putting the finishing touches on a revision to the current Rule Book; the changes include standardization of the language and a restructuring of vehicle rules. As soon as the revision is completed, the Rule Book will be posted on the BCL website and will be available in the office.

New rules are being drafted to require that property owners provide copies of permits that are required by entities other than BCL, such as Penn Forest Township and the PA Department of Environmental Protection. This will affect Members who own lake front properties, but will also require providing permits for septic systems, among other projects.

# COMPUTER & TECHNOLOGY Margo Schaefer

Over the past year I have implemented improvements in the Association's electronic communications. The goal is not to replace our legacy modes of communication (such as the printed newsletter and the bulletin board at the Indian Trail entrance), but rather to enhance our information sharing with the members.

The BCL email list was launched in February and now has over 400 members. Over the summer months, a weekly email is sent to remind everyone of the recreation events planned for the week. In the winter when activities slow down, the emails will be less frequent. If you are not on the email list yet, please sign up on the website (bclca.org) or leave your name and email address on the sign-up sheet at the BCL office.

The website now has a "Members Only" section that we will use to share information of special interest to our members. Only BCL property owners are granted access to this section. Information presented here is for the sole use of Bear Creek Lakes homeowners.

These PM manuals will aid the Directors in overseeing the preventive maintenance process and serve as a good resource. In addition, the LRP will begin the development of a survey to the Members for

Hi, it is a pleasure to see everyone enjoying the lake this summer. On any given day it is not unusual to see folks sailing, fishing, paddling, motoring (electric only of course) or just floating in tubes on the lake. We have seen a growth in popularity of Stand Up Paddleboards (SUP's) which are a great way to quietly enjoy the lake. A question that comes up periodically is "Do we need to register our SUP with BCLCA?" The answer is no. You can if you want to for identification purposes. You do not need to register them with the State either. The only State

requirement is that, similar to all other watercraft, you need to have an approved Personal Floatation Device with you when paddling.

Updates on activities highlighted in the Spring Newsletter:

#### Fisheries Management efforts.

As part of the original long-term vision developed in 2013, we have scheduled a follow-up fish population study to be conducted this fall. The results of this new study will be compared to the baseline 2013 study to gauge the success of our stocking efforts and to provide us with a plan for the next few years.

#### Bathymetric Survey

The survey was performed and you can now view the BCL depth contour map on the Members Only section of the BCL web. A hard copy is also available for inspection in the BCL Office.

#### Additional Paddle Craft launch areas

I am happy to report that mid way through the summer, this program appears to be a success. Many members including yours truly have taken advantage of this. If all goes well for the rest of the summer, we will make this permanent. I will provide an update at the September General Meeting.

Please remember, due to safety concerns, launching of any water craft is **still prohibited** at the **Dam Spillway Park**.

#### Lake Rangers


This pilot program never gained any momentum so we are not going to proceed any

#### **ENVIRONMENTAL COMMITTEE**

As we enjoy the final days of another summer, I want to take this opportunity to acknowledge the passion of our membership in expressing various points of view concerning the outside, third party actions in areas bordering our community (whether it be a maintenance building or a potential turbine facility) and move on to some additional items of potential concern.

#### Reminder: Gypsy Moth Infestations

Pennsylvania has announced that the state lacks funding to maintain the financial support program previously in effect for aerial spraying. Given the cost associated with private sector provided services and the potential legal issues that could arise when neighbors on ½ - 1 acre lots disagree on spraying, we recommend that our fellow members address these pests with an individual program, as needed. Please refer to our website for useful information.



#### "New Threats"

As incidents of Zika virus infection become more numerous and wide spread, we recommend we each pay strict attention to mosquito control efforts: especially since West Nile Virus issues can still impact us. We have posted several items on the website that will prove useful "bug proofing" your back yard. Please check these out – especially if you are a "weekender" or "vacation only" resident.

## Penn Forest Township Recreation Park Storm Water Issues

Since late June the township park construction site has experienced difficulties with its erosion and sedimentation control performance, leading to silt-laden water running across Blue Jay and Larch Drives. Your environmental and executive committees have responded with a site visit and discussion with the job foreman (June 27th), written complaints to the Carbon County Conservation District (CCD) Manager (June 29th and August 1st) and a follow-up phone conference with the CCD Manager (August 3rd).

CCD has acknowledged the control failures and is working with the site contractor to modify the size and/or configuration of the silt soxx installations that were overtopped with storm runoff the weekend of July 30th. CCD technical staff has made two inspection visits since our initial complaint (with follow-up correspondence to BCLCA on July 12th), with a third to follow in the next several days.

Your board will continue to engage CCD with ongoing correspondence and calls to report and complain of any additional failures. Finally, we will also involve our township supervisors as warranted.

As always, thank you for being a member and neighbor.

#### SPECIAL PROJECTS COMMITTEE

We have had a great amount of discussion over the past year about the need to update our community's governing documents. We have also received a great amount of feedback and many good ideas to improve our documents. Last year's budget process raised several issues with our current budget process. Owners asked for a method that would:

- Allow for notice to all members of the proposed budget prior to the meeting
- The opportunity to vote by proxy
- The ability to communicate electronically about important association issues
- Various other good ideas.

The board and the committee have moved the process along and we have discussed the document update project with two attorneys who specialize in this area of the law. (FYI Attorney Nanovic is a great resource for our association, but document rewrites are not his specialty). We are currently at the point where we want to update the documents, to require advance publication of the budget, allow proxy voting, keep the current fee structure in place and bring our documents into compliance with the requirements of Act 180. Our basic goal is to modernize the documents and to have the documents reflect the way the association has operated up to now.

Our next step will be to come to the members at BCLCA and discuss the expected legal cost to move forward. The treasurer will present an expected budget for this project and we will be seeking your input and support at the upcoming General Membership meeting.

#### **MEMBER SERVICES**

Once again we want to thank the overwhelming majority of members who pay their dues on time each year and keep the association on sound financial footing. I am pleased to report that our delinquencies are down significantly even in light of the increase in dues. We only have a handful of properties under legal collection and our outstanding accounts receivable are moving in a positive direction. We have had several properties that have been or are about to be foreclosed on by the lenders. In this case the association only receives a portion of the amount owed, however the bank will begin paying all current assessments and hopefully will quickly sell the property and we will have a new member in our community. We also have several members who have entered into payment plans and we are happy to work with any member who needs some assistance in meeting the dues obligations.

BCLCA is what YOU make it!

We are blessed at BCLCA with a great cast of volunteers that work on the board, our many committees and volunteer for other activities that make our association such a great community. 
