BUILDING RULES PARAGRAPH 2)

"All contractors who perform work within the boundaries of Bear Creek Lakes must be registered with BCLCA. Contractor work includes, but is not limited to, building, grading/landscaping, home improvements such as additions, roofing, siding, decks, the drilling of wells and the installation of septic systems."

RULES, PAGE 26 B) 4.

"All contractors working on projects must be registered with BCLCA and provide the Association with a certificate of (liability) insurance for one million dollars (\$1,000,000)."

These rules clearly require that contractors working in our community must be registered with the association. This registration is easy to get and there is no charge to register. The registration form provides the Association with contact information and proof of insurance for all contractors entering and working in our community. This protects everyone in the case of a liability issue.

Looking ahead to 2021 we are hoping and praying that things will be returning to "normal". The board is planning a full slate of activities for the coming year and we look forward to seeing our members, friends and neighbors at our 2021 events. Please watch the website and the official Facebook page for updates as we get into the new year.

I previously served on the Board and if there was an award for attending the most Board meetings I believe I would be in the running. I have also been on several committees over my 12 years in BCL.

I have reviewed the Newsletters and Board meeting motions to see what each of my committees has done in the past. I encourage all to do the same to get an idea of the past challenges. I also encourage you to submit your name to join my committee(s) when the "Call For Volunteers" invite goes out

As I collect information from past committee chairs I will compare to By-Laws ARTICLE 10 COMMITTEES. If you are interested in joining one of my committees please become familiar with section 10.3. Committee Membership.

Our BCLCA property owners have been averaging over 50 deed transfers every year for the past 5 years. I am looking forward to combining new and old ideas in satisfying the By-Laws requirements. Thanks in advance for helping to keep BCL as one of the best in the Poconos.

Environmental Committee challenges include Spotted Lantern Fly, Gypsy Moth, Storm water Runoff, preserving the quality of our lake water and well water, tree preservation and invasive grass to name a few.

Long Range Planning challenges include the BCLCA Strategic Plan, the Reserve Study and the Capital Improvement Fee to be used for future community assets. What should BCLCA create over the next 3-20 years?

As noted on the Calendar of Events and posted on the BCLCA website: "Due to COVID 19, all BCLCA sponsored activities were put on hold." ATTENTION LAKEFRONT PROPERTY OWNERS

Before installing a dock or doing any bank rehabilitation / bank protection (Bulkhead), you must register for a permit with the Pennsylvania Department of Environmental Protection. In addition, per deed covenant, BCLCA requires that docks be approved by the Association. A copy of the permit(s) will be kept on file in the Association office.

BCLCA Lake & Dam Committee

WOW! What a summer. It has been an exceptional year for the recreational activities afforded to all members of this fine community! I honestly don't think I can remember a period of time when we had so many watercraft on the lake....general boating, fishing, sailing, kayaking, swimming and evening sunset cruises. So great to see our little slice of heaven being enjoyed by all!

From the Fishery Management angle (pun intended): we stocked 10,000 Golden Shiners last fall and will do the same this fall. This was a recommendation from our aquatic biologist in harmony with the results of our fish surveys. I have had reports from several dozen fishermen regarding the fish they were catching this past year. This feedback is important to us so if I paddled up to you to chat, or I talked to you as passed my dock, I appreciate your comments. The Lake and Dam Committee is very responsive to feedback we receive from the membership. We have attached our regulations regarding the use of live bait into this newsletter. Please be sure to make all of your family and guests aware of our rules regarding fishing. Also, not really fishing related, but if you are at the boat launch area, please be mindful of boats trailering in and out of the lake. We are going to stripe a launch zone on the asphalt to keep it free of parking and golf carts and ultimately safe for everyone.

This past year we saw an enormous increase in usage at the beaches. I have to give kudos to the lifeguards for the oversight and keeping control of the sanitary conditions with COVID protocols. With that being said, the beaches are one of our amenities that are used by a large majority of members. Please be mindful of others when launching paddle craft at the beaches. This fall we are installing some additional measures to control the sand from migrating to the lake. Replenishing sand is costly and we need to make sure we are maintaining our environmental stewardship in our attempt to keep sand out of the lake. Our plan is to install an additional stone bulkhead (15'-20'), using the same Redi Rock product, just upland of the existing bulkhead to catch any sand wash in the center of the beach, while still maintaining the existing walkway in the center.

If you plan to rent a rack next year, either at the Boat Ramp or the North Beach, be sure to fill out the lottery form that is attached in this newsletter. There is also an online version of the form that you can access on the BCLCA website. PLEASE KEEP IN MIND – we try and honor special requests but sometimes it impossible to accommodate every request.

Next summer we are bringing back the sailboat races on several weekends throughout the summer. We are honoring a great past member of our community - Randy Boyer and are calling the sailboat race series the "Boyer Cup" – Randy faithfully used to host the races and made a real fun event that included his handmade certificates that he would hand deliver to you if you won the race. Stay tuned for more information on the recreation calendar.

The biggest challenge that we have in front of us is the impending evaluation of the Spillway capacity of our Dam. The state has reviewed our engineers report, using the

States updated rainfall computer model, and has responded that the existing BCL dam and spillway does not have sufficient capacity convey the Probable Maximum Flood. They have asked that the Association and its Engineer start to explore options to increase capacity to bring the Dam into compliance to DEP's protection regulations. The BCL Board has formed a subcommittee to work with the State and our engineer on this project. We have a great committee of BCL members with a vast amount of knowledge in this field. There are several design options that we will look at for this undertaking and it's important to point out that this is not a project that we may see happen in the immediate future. The review of a design by DEP, once we get to that stage, is likely to be 12-15 months. I want to make one thing clear, there is no imminent threat to the safe operation of our Dam - it is the extreme hypothetical storm event that is driving this initiative by DEP to all Dam owners in the State.

Live Bait

Greetings fellow Fishing lover!

It has come to the attention of the BCL Lake & Dam Committee that an increasing number of people (members and non-member guests who are using the lake) are using non approved live bait. A number of fishing boats have been seen with minnow buckets secured to the side or stern of the boats over the past year. The use of live bait other than worms and nymphs has been forbidden on our lake now for a number of years.

The Lake and Dam Committee would like to remind all members that a lot of thought and effort (and liaison with professionals who understand the intricacies of balancing the eco system in OUR lake) goes into managing the lake for the use of boaters, swimmers and fishers alike. As you may know we fund a tri-annual assessment of the lake as an eco-system, which quantifies the number of fish in the lake by species, and size, and just as importantly the quantifies the water quality. In our attempts to keep the water clean and as weed free as possible for swimmers and boaters, we have out of necessity, compromised the natural fish habitat. In addition, it is hugely important that we do not introduce any unwanted species of fish into our lake eco system. We therefore have over the years restricted the harvest from the lake to four fish total daily. We have restricted the fishing methods to lures, plastic worms and plastic "creatures" only, plus live worms and nymphs and of course fly fishing. ANY OTHER LIVE BAIT IS PROHIBITED. Historically, we have been successful in keeping a very healthy fish population for those who like to fish and very clean water for those who use the lake for other water recreation. So with your help, we can keep it that way.

Please ensure that you adhere to the fishing rules. Once again, you are allowed to cull (harvest) only four fish per day and that is inclusive of any bait fish you might catch.

In addition if you lease or rent your property and allow your visitors to use your boat or kayak for fishing, please ensure they are aware of the requirement.

And finally, please make sure all of your fishing vessels and trailers are appropriately tagged in accordance with BCL and State requirements and also observe PA Fish & Boat Commission rules & regulations regarding Fishing and Boating.

other learn about the natural world. The BCL Garden Club's

purpose is to share ideas related to gardening with a special focus on Pennsylvania Native Plants, Woodland Gardens, and Wildlife Gardening. This private Facebook group is open only to homeowners in the Bear Creek Lakes neighborhood, where we experience specific garden challenges with wildlife pests (like deer), invasive species (like stiltgrass, autumn olive, honeysuckle, etc.), dense rocky soil, and extreme conditions from lakeside winds to dense woodland shade.

Members are encouraged to share anything garden related, like photos of their yards and gardens, progress with gardening, plants they wish to identify, information on invasive species and garden pests, or ideas for others to implement in their own gardens. The BCL Garden Club recently held it's first in-person gatherings: first, when we volunteered with invasive Stiltgrass removal near the clubhouse and pool, and second, an open house in my own mossy garden on September 19th. It was such great fun to meet fellow garden club members face-to-face and share our love of trees and plants! Our plan is to continue this practice in the future with more in-garden visits, neighborhood garden projects, and even educational opportunities. Invasive Weeds Threaten BCL

This past summer, you probably noticed tons of tall weedy grass growing along the roadsides and covering many properties. In fact, you probably have some on your own property. This is Japanese Stiltgrass and it has been spreading across our community for years. Wherever it grows, almost no other plants Japanese survive. Stiltgrass is listed as a "Severe Threat" by Pennsylvania DCNR and if left unchecked, can change

soil chemistry, killing shrubs, and even the forest trees.

Stiltgrass is not the only invasive plant taking over our community. Garlic Mustard, Japanese Barberry, European Barberry, Lesser Celandine, and Multiflora Rose can be found across Bear Creek Lake. All of these are listed as "Severe Threats."

This invasive plant problem will only get worse if we don't do something about it now. Fortunately, we have started. Eight volunteers from a Facebook page named "BCL Garden Club" joined me for two days of work at the clubhouse. Together, we cleared almost two truckloads of Japanese Stiltgrass. The results were amazing and we're hoping to organize other projects in the future.

Going forward, I'm hoping to share detailed information on invasive species through our BCL Website, the BCL Facebook page, and the BCL Garden Club Facebook page. If there is interest, I would like to organize small seminars and guided tours to help residents better recognize and manage invasive plants on their own properties.

We all need the knowledge to identify and manage these weeds before we can hope to control them on our properties.

This year has seen an increase in new home construction and modifications. Permits are required for tree removal, additions, new homes, driveways, sheds and anything else that is outside of your existing house foundation footprint. In total we have issued 8 new home permits, four decks, one addition, five sheds, several driveway permits and numerous tree permits. Permits are not required for roofing of the existing home, windows, doors, and siding on outside of your home and any interior renovations.

The permit rules are detailed in the BCLCA rulebook and certain setbacks are described in the original or full form deeds. On the BCLCA website, under Documents and Forms, a link to the rule book and various checklists that apply to different projects can be found.

When applying for building permits in BCLCA you will be asked for all approved Penn Forest Township permits and a copy of your original deed. This shows the permit committee the side yard, rear yard and setbacks from the front pins near the street.

The pins mark the boundaries of your lot. Note that the original BCL deed may be more stringent than the township requires.

We strongly urge you to contact Todd if you have any questions about what is required, in order to avoid costly problems or delays in your project. Keep in mind that the permit committee is a volunteer position and we have other commitments in life that take up our time. We strive to get approved permits back to the member within a 2 to 3 week time frame. When planning your next project or cutting of trees I can be reached through the office to answer any questions you may have before you proceed.

Summer 2020 – One to Remember or One to Forget? Rich Berger

On March 6th the virus from Wuhan, China reached Pennsylvania as the first cases were reported. By the end of the month, the schools were closed and most of the state was subject to stay at home orders.

Here in Bear Creek Lakes, Stewart Hall was closed and community functions were suspended. Board meetings were held remotely via Zoom. The traditional start of the summer season would not occur. No spring meeting, no hot dogs and beer but in a last minute decision, the pool opened with masks required to enter or use the restrooms and a limit on capacity. In June, restrictions in Carbon County were eased – gyms were open, restaurants were allowed to operate at 50% capacity, churches were open again.

A short-lived requirement to wear masks at the beaches was quickly reversed and Members and guests enjoyed the warm summer weather. Thanks to the efforts of our badge checkers, a potential influx of unauthorized visitors was kept in check. Restrictions on Beltzville State Park led some of the overflow to our lake, but our checkers politely turned them away. Restrictions in New Jersey and New York made Bear Creek Lakes a welcome oasis of relative freedom and the rental activity was the strongest seen in a long time. This brought problems at the boat dock as many guests brought their own watercraft. Although not permitted by our rules, it was difficult to stop and the parking spots were often packed.

Most BCL functions were suspended during the summer and Board meetings continued over the Internet. With the warm weather, water aerobics at the pool had a very good season. Pickle ball continued at the tennis courts and the Book Club met over Zoom. The golf cart parade was held for the 4th of July and it was great to see all the flags and patriotic feeling along the route. At the beginning of the summer many residents were wearing masks and keeping their distance. As the summer wore on, many people relaxed and resumed normal sociability. Positive tests remained low and the bulk of the deaths in Carbon County occurred in nursing homes.

As autumn heads toward Halloween and Thanksgiving, the schools are back in various learning regimes, high school sports are active and our community is back to a quiet, relaxed time. How soon will the remaining restrictions be lifted and how will we remember this unusual year?

The Night Sky Janet Hermann

Our lovely Bear Creek Lakes community is getting brighter and brighter. As our area builds up, both within our community and generally within the area, more and more lighting is being erected. Many of these lights are all night lights which emit light not only down on the ground, but also out horizontally and up into the sky.

For our own homes, many of us want to provide light at night for security, ornament, or just to help us find our way home. There are many ways to do this - and to do this economically - which light up the area we need but leave the surrounding area dark.

Low lights, such as path or driveway lights, lights which are directed downward, lights which are fitted with caps or shields, lights on timers or motion detectors, all are efficient and effective sources of light which do not radiate light in every direction. The measure, they say, is that light fixtures should be focused downward so that the angle of light does not exceed 45 degrees from the ground. This is sufficient to light up a driveway or house front without sending light into the sky or over to your neighbors.

Brightening the night sky is not only costly, it is known to disrupt wildlife and the ecosystem and it also can interfere with our own sleep/wake cycle.

There is a wealth of information available for the asking – www.darksky.org is a good place to start.

Let's keep the stars shining over Bear Creek Lakes!

Stewart Hall

Roger Green Stewart



We had fresh October snow this morning, a reminder that our lake is 1,500 feet higher than surrounding communities like Jim Thorpe and Lehighton. A reminder also that my Board responsibilities now also include Stewart Hall itself which bears my father's name. Right now, there isn't much to say about the Hall itself

since the Coronavirus has closed down all activities in Stewart Hall until at least mid-December. However, some of Stewart Hall's history is actually quite interesting . . .

Stewart Hall itself dates back to the beginning of the Bear Creek Lakes development in 1964 – and was built by my Great-Uncle, Josiah Behrens, along with the dam and a recreational development for up to 1,100 homes.

Historically, our current 120-acre Bear Creek Lake was actually the third lake built on Bear Creek. The first was a 5-acre lake built by Francis Behrens in 1906. It was located about 300 yards west and downstream of the narrow Behrens Road bridge which now crosses Bear Creek itself. The second 2-acre lake was built by Josiah Behrens in 1930, still exists and includes a millrace extending from our current dam to a waterwheel at the eastern end of the old barn 100-yards east of Behrens Road. The millrace & pond are currently owned and maintained by Nancy (Behrens) and her husband, Tarone.

Meanwhile back in 1960 my dad, Roger Daniels Stewart and his wife Julia, were very excited to hear about this "new Bear Creek Lake" in development. In 1960 they bought and moved into one of the dozen single-room hunting cabins on the south shore of Bear Creek itself. A small iron stove, outhouse, and a nearby spring -- but otherwise no heat or water.

Even so, Dad quickly fell in love with our lake and its rapidly developing and friendly community. While his professional work for the USA Naval Research Laboratory included designing telescopes and photographing nuclear explosions, his afterwork passion was in painting: signs, cartoons, party announcements, historical Mauch Chunk

scenes -- plus other things of dubious legality. Like the naming of our road -- which had for years been called just "Star Route A" by the Jim Thorpe Post Office. One night Dad just put up official-looking signs calling it "Behrens Road", and the name stuck. It's been officially called that since.

Once you learned his artwork style, you would find hundreds of examples of it all around the lake on signs, trees, houses, boats -- including "Frisky" the bear cub still featured on our shirts and signs today. When he wasn't volunteering for the Lake, he taught weekly painting classes at the "Stewart Hall". After Dad passed on in 1992, the Board unanimously named it "Stewart Hall" in his memory.







Obituaries

Bill McKissick



Bill, a former long time resident of Bear Creek Lakes, passed away on September 23, 2020. He purchased his lot in BCL in the mid 70's and shortly thereafter built a house on what is now 134 Midway Drive. In the 80s Bill was in

charge of security in BCL. He enjoyed participating in the golf cart parades for the 4th of July.

He was devoted to the community of Penn Forest and the Penn Forest Volunteer Fire Company # 1. He was a life member and was instrumental in raising funds for the Fire Company, organizing block shoots and working bingo. He served as President and was Captain of fire police for years. When the Fire Company housed the Penn Forest ambulance, Bill and his late wife Marie volunteered many hours along with Walter and Joan Hunsinger.

James E. Smith Jr.



James E. Smith Jr. of Bluejay Drive peacefully passed away in the Coaldale Hospital on January 23, 2020.

Jimmy, as he was known to all his family and friends, was a native Penn Forest resident and was one of the few residents of our community left that could remember when everyone knew who lived on the mountain or as it was known as the "Pine Swamp".

Jimmy was a very community minded man who loved his family and neighbors and was always there to lend a helping hand when needed. He was one of the charter members of the Penn Forest Fire Company and spent many hours working to form the Fire Company and securing the first ambulance service to our community.

He held the position of Fire Company president for many years. Not many people knew how kind he was. It was his wish that the community have a full time ambulance service on the mountain so he and Barbara donated the property on 903 where the Lehighton ambulance is housed in memory of his parents, J. Edgar and Violet Smith. He always said if it "saved one life, his purpose in life was fulfilled".

Jimmy also served on the Board of Directors of the Mauch Chunk Trust Company, was a member of the Jim Thorpe Masonic Lodge, the Rajah Shriners (for which he was known to hold car shows in his yard and donate all the proceeds to the Shriners Children Hospital), he was also a member of the Jukebox Cruisers Car Club and was President of the former Western Pocono Association.

His love for Bear Creek Lakes began at its inception. All of the roads in our development are made of a shale base from the pit he and his family owned and many of the original driveways were put in by his company. When he sold the business, due to health reasons and could no longer maneuver in his two story house, it was never a question on where he wanted to live.

He is survived by his wife Barbara to whom he was married to for 53 years.

Stanley Turel

If you have ever gone to Penn Forest Fire Co. #1 for breakfast, more than likely, you have met Stanley Turel. You might have seen him standing behind the potatoes (with or without onions), ham, bacon or sausage, or possibly handing out toast

BCLCA lost Stanley on September 11, 2020. He was a member since Columbus Day of 1963. Stanley's daughter Cheryl Turner Daumer came to the fire company breakfast in October and gave us a little information about her dad.

Cheryl Turel Daumer

My dad was born with a collapsed lung, weighing 3 pounds and given his last rites before he was one hour old. His mother had pneumonia and they were not sure either one would make it. The nurse's named him. He had rheumatic fever as a child and had to eat bananas at every meal. Afterwards he hated bananas. He loved to play basketball and knocked a front tooth out when he got hit by one when he was younger.

He was involved with two fire companies for many years. Se-Wy-Co, Bethlehem PA and Penn Forest Fire Co. #1. He was a CPR, Standard and Advanced, first aid instructor. I was his "dummy" since I was in third grade and I could pass all three courses just from listening to him teach. He worked for Bethlehem Steel and when he was younger he was a pin boy at Liberty Bowling alley. After his retirement he worked for ARP Healthcare then for Summit Bank which became Bank of America.

Dad was also the lower Saucon Township treasurer from 1976 to 1980. He was also the tax collector.

One of his most proud moments was when he was given the Young Man of the year award from Hellertown, Lower Saucon, Jaycee's in 1974. My dad loved his 57 years with SE-WY-CO, Bethlehen and roughly 37 Penn Forest Fire Co. #1. He was a Fire Police Captain for many years, was also an EMT and a Fire Police for us.

Dad was always a great mentor, taking someone aside to correct them, rather than saying what was wrong in front of others.

The pager/scanner was always open so he could hear what everyone else was being called for. That is why he was buried with a scanner.

My sister Lori lives in Effort and has an antique and collectibles store called "The Copper Goose. In case you are in the area, stop in and say your are from BCL.

My husband Bob and I own R E Daumer Trucking and will be spending time in BCL. We absolutely love the area.

Rules Committee

A number of BCL Rules were updated this past year and some others are being reviewed. Rule changes are discussed at Board meetings so please attend these meetings to keep up to date on what is happening in our community. As always, a wealth of information is available on the BCL site and in the 'Members Only' section. www.bclca.org Here are the rules that were added or revised for this past year;

• Building Regulations and Property Maintenance section, Rule #23.

Due to the possible presence of unknown contaminants and/or pollutants, the use of Road Millings within the Bear Creek Lake boundary is prohibited. It includes any millings whether mixed with any other material or covered in any way.

Health, Safety and Environment Rule #5

Littering i.e., the discarding of trash, garbage, or other waste including pet waste upon property owned by BCLCA without regard for placement in proper containers, is not permitted. No warnings will be given and violators are subject to a fine up to \$300.00. Pet owners that do not clean up after their pets may be subject to a littering fine.

Pet Rules and Regulation Rule #4

Pet owners are expected to clean up after their pets if off of their property. Pet owners that do not clean up after their pets may be subject to a littering fine.

General Rules Rule A2

No person shall use any BCLCA common area or unimproved private lot for overnight camping.

Swimming Pool and Beach Area Rules #9

Reliance on diapers of any kind is prohibited in the lake or main pool. Non-potty-trained or incontinent individuals are prohibited from swimming or wading in the lake or pool while at a BCLCA facility. It is a violation of this rule to remove the diaper or covering prior to entering the water. Those that are not potty-trained, or incontinent can use the wading pool located at the pool. Repeat offenses will be considered a littering violation. See fine schedule.

Swimming Pool and Beach Area Rules - Information Section

Swimming at the beaches when there is no lifeguard on duty is at the risk of the swimmer and/or the responsible person for children under the age of 12 as noted in Rule 7 above.

Building Regulations and Property Maintenance - Information Section #4

Accessory buildings include the following: detached garages (built prior to 9/07); storage sheds; boat/car/ RV storage; shelters, gazebos; swimming pool. Temporary structures such as fabric covered metal/wood framed structures to follow all requirements except for Township permitting.

Building Regulations and Property Maintenance - Information Section #7

Storage units not considered permanent structures can be maintained only for the duration of the permitted construction. Storage units for any other temporary purpose, sometimes known as 'Pods', are allowed on site for no more than thirty (30) days.

Business/Commercial Ventures and Yard Sales Rule 1 d.)

All Garage/Yard Sales must be registered with the BCL Office.

General Rules for Motor Vehicles – Rule #3

Vehicles belonging to BCLCA Members must have a BCLCA sticker prominently visible from the rear of the vehicle, or a BCLCA vehicle placard/permit hung from the vehicles rear view mirror in plain sight for security checks. As of January 1st vehicle placards/permits from the previous year are expired and therefore will no longer be valid at any BCLCA amenity. Vehicles without the proper BCLCA identification are subject to citation.
