We have a few groups of people who are charged with checking badges and stickers: Security routinely patrols, we have paid badge checkers, we have our crime watch committee members and from timeto-time board members will also check. Our Badge Checkers and Crime Watch Members all carry yellow "Crime Watch" badges and our Pool Gate Attendants carry badges to help you identify their authority to ask for badges. Please cooperate with them as this is the only method that we have for keeping BCL amenities for the use of our members, guests, and renters. If you find any of our staff or volunteers to be discourteous, please ask their name and report the interaction to the office. We will follow up. All our "checkers" have received training in how to approach members in a polite, respectful manner. They are also trained to avoid confrontation and to contact Security in the event of an uncooperative member or quest.

As a board we work hard to maintain and improve our community. We strive to communicate accurate timely information on both the website and through our email list. We also use our official Facebook page as another source of information. If you are looking for accurate information about the rules or the boards discussions, check these sources. There is a great deal of inaccurate information on other social media sites, and it is no wonder that so many members get confused by this.

I again want to thank all of you and our board and committee members for all of your cooperation and hard work. That is what makes Bear Creek Lakes such a great community.

Permits

This past summer has been very busy. There were four new homes, sheds, additions and many tree permits inspected and released. A big thanks to my tree inspectors Bob Cappello, Bill Malone and Frank and Mary Ewerth, who fill in for me. BCL now requires permits for all types of fencing. Once a permit has been issued by Penn Forest Township, fill out a permit checklist and drop off your paperwork at the office for review. Any questions regarding permits can be answered by the office staff or myself before starting the project.

DO I NEED A PERMIT?

Besides the normal permits that are needed for trees, driveways, new construction, additions/attached garages, decks, sheds, and fences, these are some questions that may assist you in the future:

- If I am getting a new roof or new siding? No permit needed from BCL but check with the Township on their rules.
- For solar panels? No permit needed from BCL but check with the Township on their rules.
- For an in-ground pool and above-ground pool? Yes-BCL permit needed but need Township permits first.
- To replace septic system? Yes. We need to see Township's permits, the contractor's Certificate of Liability Insurance (including General and Auto Liabilities), and erosion control on-site. You will also need a BCL tree permit if you need to remove trees to make room for septic.
- If I'm replacing deck boards on top of deck? No permit needed from BCL but check with the Township on their rules.
- If I need structural repairs on deck? Yes-BCL permit needed but need Township permits first.
- To put in an outside hot tub? Yes-BCL permit needed but need Township permits first.
- To put in a cement slab? Yes-BCL permit needed but check with the Township on their rules.
- To replace a shed that is already on my property? Yes-BCL permit needed but need Township permits first.
- If I am putting in a cement patio? Yes-BCL permit needed but check with the Township on their rules.
- If I am putting in a Walkway? Yes-BCL permit needed but check with the Township on their rules.
- If I am putting up a gazebo? Yes-BCL permit needed but check with the Township on their rules.
- If I would like to put up a greenhouse? Yes-BCL

- permit needed but check with the Township on their rules.
- If I am putting a roof on my open deck? Yes-BCL permit needed but check with the Township on their rules.
- If I am putting up a pergola? Yes-BCL permit needed but check with the Township on their rules.
- If I am extending my driveway? Yes-BCL permit needed but check with the Township on their rules.
- If I am recoating my paved driveway? No permit needed from BCL.
- If I am getting more stones for my driveway? No permit needed from BCL.

We finally got the all clear to remove the ban on September 24th, 2021. It is my first year serving as Lake and Dam Director and will be working hand in hand with Terry Baughn and Pete Matone to try to fill the shoes of Jack McGeehan. Jack will be serving on our committee and will still have a pivotal role by answering our questions and helping with dam inspections.

The two areas we are currently working on are the storm water abatement problem and the rewrite of our declarations or deed covenants.

Storm water project: We are in the process of getting updated pricing for this project. The last costs we received from our engineering company were higher than the previous ones. Much of this increase was due to the inflation of materials cost that occurred over the past few months. It's our hope that these prices for our construction material have come down

as they have for the general building materials. We will be coming back to the board soon with new figures and discuss how we are going to pay for this important work to be accomplished.

Declarations rewrite: We submitted our draft to our attorney who reviewed them and sent then back with his comments. We have integrated those comments and plan to set up distributions of the draft to all members in the near future. This will be followed by town meetings in order to give everyone a chance to voice their opinions and ask questions. It's very important that we get these new declarations passed in order to bring our governing documents up to the current HOA laws.

Currently, the entrance at Stewart Hall has been raked free of its old mulch into small piles for use next year as a base for the newer mulch to be placed. Additionally at the entrance, a resident, Ruth Heisel, has been kind enough to supply us with 24 Iris bulbs which have been planted. If you look, you will see their small stems protruding along the perimeter and inside towards the trees. Hopefully we'll see the results of these efforts in early spring. They many or may not bud the first year planted according to Ruth.

If any resident wishes to contribute bulbs or small bushes, upon approval, the committee will strategically place them on common properties. This would be cost effective.

Inspection of our entrance signs along RT 903 and at the realty office finds them in sufficient conditions for the balance of this season. Plans for next year will be worked through.

Several mum pot plantings will be placed along the stairway at the Stewart Hall entrance. In addition, there will be a replacement of several arborvitaes along the pool fencing in our parking lot. They are, like many of our trees, dying from too much rain. Replacements are based on appropriate timing, conditions and weather permitting.

Come next season, members willing to volunteer or expressing an interest in helping with landscaping and plantings will be most welcome.

Don't fall victim to online scams! Here are a few tips to help keep you safe.

- * Make sure you keep all software updated. If you are using Windows 10, follow the steps below.
- 1. To review your Windows Update settings, head to Settings (Windows key + I).
- 2. Choose Update & Security.
- 3. In the Windows Update option, click Check for updates to see which updates are currently available.
- 4. If updates are available, you will have the option to install them.
- 5. Make sure updates are set to install automatically.
- * Never give out personal information, bank information or credit cards
- * Never assume that someone who knows things about you is someone who can be trusted.
 - o It is very easy for scammers to get information about you online.
- * Never go to a website because a caller or an email told you to.
 - o The IRS will not call you or email you.
 - o Microsoft or Google will not call you.
 - o A tech support company will not call you and ask you go to a website.
 - o Your car warranty is not expired.
 - o A stranger will not call you to say one of your relatives needs money.
 - No one who won the lottery, an inheritance or a court settlement needs your help to get money out of their country.
 - o Don't buy gift cards and provide the codes to anyone.
 - o Never give out your multi factor codes over the phone or email.

These are all common scams. Don't trust anyone that you don't know. If a message is from someone you know and it looks odd, pick up the phone and call the person on a known phone number. Don't trust emails or phone call to you.

Security

BCL Security is provided by Garda World but is supplemented by Crime Watch all year-round and the Badge Checkers during the summer months. Security is available seven days a week as is Crime Watch.

There are approximately twenty members who participate in Crime Watch. These devoted volunteers serve without compensation, other than the satisfaction of working to keep our community a peaceful place to live. A schedule for volunteers is sent out every week, and it is filled very quickly. Our volunteers are very dedicated to their duties. The main concerns are to check all amenities to ensure they are being used by our residents. Thus, the importance of having identification on your person and all types of vehicles.

This year, we will now have your badge number on the guest placards.

Our Security does not have a set schedule; it varies to keep potential troublemakers guessing. Security enforces our rules. Our rules are posted on the BCLCA website. All new members are given a copy of the rules and it is recommended that all members review the rule book. The most frequent infractions are parking at the common areas without a sticker or placard, not having a badge at the pool or beach, parking a vehicle in the boat trailer space, and failure to have a BCL sticker on watercraft.

If you have a boat rack, it is important to notify the office or Security if someone else is using your rack or If you see watercraft without BCL stickers.

A new phone system has been set up in our office. When the security number is called it will ring simultaneously in the security office and at Garda World Services. This will give our officers a chance to receive calls if they are in the office.

BCL is one of the safest communities in the Poconos. We are here to protect and serve our residents

Speed Sign is placed in location for data collection based on :

Calls/concerns from BCL Member with heavy traffic in relationship to speeding issues.

BCL Member is requesting a placement of permanent speed bump.

Once a "work order" has been received from V.P. or Security , the Speed Sign is put in location for a period of appx 2-3 weeks for "Facing" and "Opposing" Traffic.

Data Collection:

Total traffic daily.

Total traffic per hour.

Min and max speed in hourly increments (Max Speed is "over 25mph")

If data collection shows certain "timeframes" in relationship to speeding issues, "Security " will be informed and usually "on-sight" studies are done.

Data from each location is compiled together for review and /or presentation by the V.P. /Security during next Board Mtg, if needed.

David Quinn




Newly elected to the BOD, David Quinn and his family have been living in BCL for forty years. The peace and serenity of the area is what attracted them to our community.

Rules Committee

New rules and modified rules are shown below and the updated Rules Book is on the member website. We encourage all members to familiarize themselves with the BCL rules. Rules are in place to protect our lovely neighborhood and the members as well.

The Board is discussing a change in how new/modified rules are enacted to hopefully give members more insight and opinion on new rules prior to them being enacted. Stay tuned for more on that or better yet attend or log into the Board meeting by Zoom. Getting cooler now, nothing better than curling up with a hot cup of your favorite beverage and the Board meeting on your favorite device.

Here are the latest new and revised rules:

 All boats must be registered at the BCLCA office and identified with a set of BCLCA stickers, visibly displayed above the water line on both sides of the bow of the boat. Beginning in Calendar Year 2021, all boats will be required to be re-registered with the new stickers and a registration fee of \$10.00 per boat will be charged to help cover administrative costs. BCL boat stickers must be removed if the boat is sold. Only members may register boats.

- All contractors who perform work within the boundaries of Bear Creek Lakes must be registered with BCLCA for work that either requires a BCL permit or is in excess of an aggregate amount of \$5,000 per contract. In addition to registration, if required, acceptable insurance documentation including but not limited to, Commercial General Liability and Vehicle Liability insurance, must be provided at time of registration. Contractor work includes, but is not limited to, building, grading/landscaping, home improvements such as additions, roofing, siding, decks, the drilling of wells and the installation of septic systems.
- The Board of Directors of BCLCA shall have the power to enforce these Rules and Regulations. The effective date for any new or amended rule(s) will be 45 days following approval by the BOD except as deemed by the Board.
- Building Regulations Rule #18 Building contractor and lawn care/landscaping signs are permissible only during the period the work is in progress. Exception is made for displaying of Security Systems/Monitoring signs. No contractor sign may be larger than nine (9) square feet. Building contractor signs must be removed within nine (9) months of the issuance of the building permit or at the time an Occupancy Permit is received, whichever occurs first. Members are responsible for ensuring that contractors comply.
- New Boat Rule # 18 No boats/vessels or other floating devices are permitted to be permanently or semi-permanently moored except as allowed by the Board of Directors.

New General Rule #11 No loud parties or other neighborhood disturbances are permitted between the overnight hours of 11:00PM-8:00AM Sunday-Thursday and 12PM-8AM Friday-Saturday.
